If one cannot find such a brand he may purchase a brand that does not have a 'kosher for passover' symbol provided that he carefully checks the grains <u>before</u> Pesach for any extraneous matter. Some rabbis do not permit quinoa on Pesach.

²⁰ Soy and Rice are kitniyos and their 'milk' may contain chometz. Under normal circumstances one mustn't consume them on Pesach. Those found in the link below are chometz free and may be consumed by someone who is allowed to eat kitniyos (e.g. one who is ill). Of course, one can choose to make <u>Almond milk</u> at home for Pesach. Should someone have a choice between Soy Milk and Rice Milk then Soy Milk is the better choice as Soy wasn't introduced to Europe until about 100 years, ago long after the kitniyos decree. It is recommended that those who require these products ideally purchase them before Pesach. Here is the OU's list of acceptable Rice Milk for those who need it: Rice Dream Enriched *Unsweetened* Original; Harris Teeter; RiceSense Enriched; Full Circle; Hy-Vee; Meijer; Nature's Place; Shop Rite; Market Basket Enriched; Price Chopper Enriched; Wild Harvest Enriched
